# The Historical Society of the Courts of the State of New York

The Society was launched in 2003 with the mission of preserving the legal and judicial history of the State of New York. It seeks to foster scholarly understanding and public appreciation of the rich legacy of the New York courts, the legal profession and their contributions to the State and nation.

The Society presents programs on a wide variety of topics about New York's legal history that are CLE-accredited; it publishes books of historical interest and a scholarly periodical; it has initiated a program to collect the oral history of, among others, former New York Court of Appeals Judges; it exhibits New York legal history in Court of Appeals Hall and at the New York State Judicial Institute; and it has created a website that contains a rich and growing library of New York judicial history.

The Society holds an annual lecture each year at the New York City Bar, as well as lectures held at other forums across the State. The programs feature guest lecturers who are prominent lawyers, jurists and law school and university professors who are experts in their fields.

**J**UDITH S. KAYE was born and raised in Monticello, New York. She attended Barnard College and received her LL.B. degree from New York University School of Law in 1962, graduating cum laude.

Immediately following law school, Judge Kaye entered private practice at Sullivan & Cromwell in New York City (1962-1964), and was in-house counsel in the law department of International Business Machines (1964-1965). From 1965 to 1969, she was part-time assistant to Dean Russell Niles of New York University School of Law (1965-1969). In 1969, she joined Olwine, Connelly, Chase, O'Donnell & Weyher as a litigation associate (beginning on a part-time basis, with three young children), and was later named a partner, in this mid-size New York City commercial law firm, where she remained until 1983.

That year, she was appointed by Governor Mario M. Cuomo to the highest court of the state of New York, the Court of Appeals, becoming the first woman to occupy that post. In 1993, Judge Kaye made history again when Governor Cuomo appointed her Chief Judge of the State of New York, the first woman to occupy that post, adding administrative and executive responsibili-

ties for the state court system to her judicial role. The only New York Chief Judge ever to complete a full 14-year term, Judge Kaye was re-appointed by Governor Eliot Spitzer in 2007, to a term that ended December 31, 2008 due to the State's mandatory retirement provisions. She recently became Of Counsel to the law firm of Skadden Arps Slate Meagher & Flom.

While Judge Kaye is recognized as a national leader in the judicial system, it is her dedication to her home state that sets her apart from her fellow jurists. During her tenure, Judge Kaye led countless projects to make the New York court system more efficient and responsive to the needs of all residents. Her most noteworthy initiatives include creating problem-solving courts, including drug and family treatment courts, domestic violence courts, mental health courts, and community courts; implementing a Commercial Division of specialized commercial courts for cost-effective resolution of business disputes; establishing a statewide network of child-care centers for litigants in courthouses; and designing the Adoption Now program which has produced faster adoptions and more streamlined procedures for children in foster care and their families.

Judge Kaye has dedicated herself to educating the public and legal community about the courts. She has lectured widely throughout her State and the nation, and is the author of numerous publications. Her most noted articles deal particularly with legal process, women in the law, state constitutional law, professional ethics and the problem-solving courts she implemented throughout New York.

Chief Judge Kaye's commitment to service extends beyond the bench. She has served as chair of The Permanent Judicial Commission on Justice for Children, on the Board of Directors of The Dwight D. Opperman Institute of

Judicial Administration, and on the Board of Editors for the New York State Bar Journal. She is a founding member of Judges and Lawyers Breast Cancer Alert, a member of several bar associations, and a Trustee of The William Nelson Cromwell Foundation. She was President of The National Conference of Chief Justices. She has lectured widely and authored numerous publications.

Judge Kaye is the inspiration behind the formation of The Historical Society of the Courts of the State of New York, and has been an important guiding force in its growth and development.

## Cuomo Selects First Woman For High Court

Judith S. Kaye, a partner in a Manhattan law firm and vice president of the Legal Aid Society, was nominated by Governor Cuomo yesterday to be the first woman to serve as a judge on the state's highest court.

The appointment of Mrs. Kaye to the Court of Appeals is subject to confirmation by the State Senate.

At a news conference in his office at the World Trade Center, Mr. Cuomo praised Mrs. Kaye's "extraordinary qualifications" and called her a "a lawyer of unusual ability, integrity and determination."

Referring to the absence of a woman on the court, he said, "in addition to adding excellence to the court, the appointment of Judith Kaye erases a stigma it has borne for too long a time."

### No Experience as a Judge

Mrs. Kaye, a partner at the firm of Olwine, Connelly, Chaso, O'Donnell & Weyher, has never been a judge. Mr. Cuomo said this would not be a handicap and noted that several Court of Appeals judges had not previously served on the bench, including Adrian P. Burke, for whom he once was clerk.

"Like other great Court of Appeals judges who came to the bench directly from the practice of law," he said, "her day-to-day life as an advocate has demonstrated the character, temperament, capacity for collegial activity and ability to articulate that are essential."

Mrs. Kaye said she felt both "inexpli-

*“The considerations favoring law-trained Judges are all the more compelling where, because of the nature of the charges, a jury trial has been provided by law. While lay Judges bring a welcome sense of community values and practical wisdom to the court-*

*room, when a trial is conducted before a jury, those perspectives are furnished by the jury. The Judge’s role in a jury trial is necessarily more technical. The Judge must assure that the rules of evidence are complied with, and that the jury is correctly instructed on the law. Despite the courses prescribed for nonlawyer Town and Village Justices, their training in the law, and especially their exposure to the complexities of a criminal jury trial, do not approach a law school education and experience at the Bar.”*

## **Cuomo Nominates Judith Kaye For Top New York Judicial Post**

ALBANY, Aug. 12 — Gov. Mario W. Cuomo today announced that he has nominated Judge Judith Kaye to be the next Chief Judge of the State Court of Appellate Justice. Judge Kaye, a Democrat, is the first woman to be nominated for the post. She has served on the Appellate Division of the State Court of Appellate Justice since 1981. She is also a member of the New York State Bar Association and the New York State Judicial Conference. She has received numerous awards and honors for her work in the judiciary.
