

ADMINISTRATIVE ORDER TENTH JUDICIAL DISTRICT—NASSAU COUNTY

Pursuant to the authority vested in me, in accordance with the recent operational protocols issued by the Chief Administrative Judge for the Trial Courts of the Unified Court System, and after consultation with the Chief Administrative Judge and the Deputy Chief Administrative Judge, I hereby order that the following rules be put into effect in the 10th Judicial District—Nassau County until rescinded. This order amends and modifies the Administrative Order of this Court dated March 17, 2020, which otherwise remains in full force and effect, by replacing the designated sections below with the following text.

The March 17, 2020 Administrative Order, Section 3, paragraph B, pertaining to nonessential matters in the Superior Criminal Court is hereby replaced with the following:

For out-of-custody defendants, all non-essential matters are adjourned administratively to a date on or after May 30, 2020 or to a date to be determined by the assigned Judge in consultation with the Office of the Nassau County District Attorney and the Defense Attorney. For in-custody defendants, all matters are administratively adjourned until May 7, 2020 or to a date determined by the assigned Judge in consultation with the Office of the Nassau County District Attorney and the Defense Attorney. From the date of this order until May 7, 2020, each assigned Judge shall undertake a review of each case where a defendant is in-custody. Under no circumstances shall a matter involving an in-custody defendant be adjourned to a date that is more than thirty (30) days from the date the matter is reviewed by the Judge. Essential Staff and/or Chambers Staff shall be responsible for notifying the District Attorney and the Defense Counsel or pro-se litigants of the adjourned date.

The March 17, 2020 Administrative Order, Section 6, paragraph A, pertaining to nonessential matters in the District Court is hereby replaced with the following:

For out-of-custody defendants, all non-essential matters are adjourned administratively to a date on or after May 30, 2020 or to a date to be determined by the assigned Judge in consultation with the Office of the Nassau County District Attorney and the Defense Attorney. For in-custody defendants, all matters are administratively adjourned until May 7, 2020 or to a date determined by the assigned Judge in consultation with the Office of the Nassau County District Attorney and the Defense Attorney. From the date of this order until May 7, 2020, each assigned Judge shall undertake a review of each case where a defendant is in-custody. Under no circumstances shall a matter involving an in-custody defendant be adjourned to a date that is more than thirty (30) days from the date the matter is reviewed by the Judge. Essential Staff and/or Chambers Staff shall be responsible for notifying the District Attorney and the Defense Counsel or pro-se litigants of the adjourned date. The March 17, 2020 Administrative Order, Section 7, paragraph A, pertaining to nonessential matters in the Town and Village Courts, is hereby replaced with the following:

For out-of-custody defendants and civil cases, all non-essential matters are adjourned administratively until a date on or after May 30, 2020. For in-custody defendants, all matters are administratively adjourned until May 7, 2020 or to a date determined by the assigned Judge in consultation with the Town or Village Prosecuting Attorney and the Defense Attorney. From the date of this order until May 7, 2020, each assigned Judge shall undertake a review of each case where a defendant is in-custody. Under no circumstances shall a matter involving an in-custody defendant be adjourned to a date that is more than thirty (30) days from the date the matter is reviewed by the Judge. Essential Staff and/or Chambers Staff shall be responsible for notifying the Prosecuting Attorney and the Defense Counsel or pro-se litigants of the adjourned date.
